Several awareness lectures for breast cancer were presented as well as some medical services and medical examination that concerned

with women's health. Dr. Nourah Al- Shimari, Specialist Obstetrics & Gynecology, Dar Al Shifa hospital, started the first lecture with reviewing breast cancer percentage which is about 1 in 10 women, pointing that causes of breast cancer are early onset are genetic history, late marriage, women without breastfed experience, early age menstruation. Indicating that breast cancer

is the second most cancers woman's risk as the first is cervical cancer, pointing out that early detection and contributes in treatment significantly, especially in the age of forty, as signs and symptoms of the disease are not appeared.

He stated that Information & Communications Technology Group, always looking forward to provide the company with the best services to obtain employees satisfaction in all groups through constant communication and renders attention to all complains and remarks related to the electronic system in order to find the best solutions for them, as per interview details below:

#### · Explain briefly about the different projects operated by Information & **Communications Technology Group?**

Information & Communications Technology Group, implemented a number of projects recently that created a quantum leap for KOTC in the field of Information Technology, such as, the completion of the implementation of Aaly project phase-I. The HR System Integration to automate and integrate the standardized HR business processes across KPC & K-companies. Currently the phase-II of Aaly project has been commenced and we are in the process of implementing the largest integrated technology solutions among the K- Companies, which consist of "Unified Learning Management System", Integrated & common HR Portal, Consolidated Management Reporting Dashboard.

As Phase-1 of the project has been executed, related to secured electronic identity for the company's employees in cooperation with the Public Authority for Civil Information to be used in the completion of the official electronic transactions, where an electronic signature "password" was issued for each employee, in order to apply the mechanization of the e-services provided by Human Resources & Career Development Group in the company in

order to issue official certificates such as salary certificate, to whom it may concern certificate and other official certificates.

Launching a new printing system "Print anywhere" with Print anywhere system, users be able to get there printed documents, scan to their mail and PC, approved by CEO, as well as printing machines and scanners all over the company, where Information & Communications Technology Group provided a printer for each manager and his secretary and scanner for each team leader and his secretary, with print anywhere system, users be able to get there printed documents, scan to their mail and PC by using their ID card or employment number or username and password. The new printing system reduced costs by decreasing the number of printing machines, ink and papers. Information & Communications Technology Group conducted a Handson training to all employees on the new system. The new system increase employee's productivity and enhance security of their information. One of achievements of Information &

Communications Technology Group was "Fleet Management System" through their cooperation with Fleet Engineering Group to operate the Oracle system onboard all the company fleet tankers

as well as activating phone and video call and connecting them with the Oracle system and Fleet Management System, to issue purchasing and delivery orders onboard accordingly, also 5 new applications were added to the Oracle system to serve all groups such as Purchasing and Contracts, Civil projects, HR, Marine Agency, LPG "Shuaiba" & "Umm Al Aish" branches.

Cisco Jaber Project, Information & Communications Technology Group has introduced two new services which are extension on the mobile phone &video call facility from any device (Mobile/PC) on the internet to desktop phones and meeting rooms.

"Extension on the Mobile Phone" with this facility, office desktop phone extensions can be configured on your iPhone or Android-based mobile devices which are connected to the internet. This needs a configuration to be done on the IT side, based on the phones (IPhone or Android). So whoever interested to have this facility, which start providing your phone type, by this facility you can make voice as well as video calls to other KOTC employees. In video call Facility, you can also have a video call to the desktop phone, which has a built-in camera, or just a voice call to the desktop phone from anywhere by clicking on the button below which is

being attached to your signature. Launching the new internal electronic website of the company will provide a lot of information, software and applications to serve employee in one easily accessible place to accomplish his work without moving between applications and files saved in different places on his PC, as it contains all company events, news and circulars as well as KOTC magazine, local and international newspapers, weather and prayer timings.

The website contains a web page for each group allowing their employees to manage the page content such as uploading group files, creating calendar and scheduling of group meetings and activities. On the personnel level it contains a profile for each employee to upload his personal information and photo. Information & Communications Technology Group conducted a training to all employees on the new system covering the maintenance of the website in regular basis as well as developing and enhancing it and adding new applications and software.

#### Diabetic Employee has to Inform his Colleagues if He Needs a Medical Treatment

# Dr. Fahad Al-Obaid: Work Environment is an Important Part of Diabetic's Life

Dr. Fahad Al-Obaid, Medical Advisor/Specialist Occupational Medicine & Public Health, confirmed that dealing with diabetes in work environment is an important part of diabetic's life. Pointing out that maintaining the blood sugar levels needs serious planning and preparations.

He mentioned in his interview with "KOTC" magazine that diabetic employee has to Inform his manager or colleagues as a personal decision stressing on the necessity of reporting his medical case to some certain persons, in order to assist him if he needs a medical treatment, offered a group of tips for diabetes to help them avoiding diabetes complications as mentioned through his interview.

#### Regular snacks throughout the day to maintain the regularity of blood sugar levels

Kuwait occupies fifth position globally in terms of the prevalence of diabetes and the number of patients is doubled

#### First tell us about the rate of diabetes disease prevalence in Kuwait?

Chronic diseases considered one of the major causes of death and disability in Kuwait, where the World Health Organization estimated chronic diseases death rate with 72% of all deaths causes in Kuwait during 2002, as modern statistics revealed that Kuwait occupies the fifth position in the world in terms of the prevalence of diabetes in adults as recorded in local reports that number of diabetic patients is doubled in Kuwait over the past decade to reach 14.6% of the population in 2010, which is equivalent to 180,000 of the total population.

#### How diabetics should deal with the disease during the working hours?

Dealing with diabetes in work environment is an important part of the patient's life, as well as occupational adjustment with this situation in some cases could be difficult and dangerous, especially when the patient is too busy with work issues and neglects to eat, and forgot to check blood sugar during working hours. On the other side there was a study in UK found that people who suffer from diabetes are afraid of being labeled with it in the workplace and don't allow their blood sugar levels to be too high during the day due to work priority other than managing and organization of diabetes.

# • How the patient maintain the level of sugar in the blood?

The main goal of diabetes treatment is to maintain blood sugar levels as close as possible to the normal level and prevent the incidence of complications associated with diabetes as some cases of diabetic who may need a healthy dietary routine and daily exercise to control the level of sugar in blood and there is some diabetes require medicines for diabetes treatment, either orally or by injection in addition to their commitment to follow a healthy diet and appropriate sports program. Diabetic needs regular check-up and conduct extensive examination as well as cooperating with medical care team to reach the

most important goal of controlling blood sugar levels and avoid resulting complications, in addition to follow the advice of a dietician. Education and training programs is considered a basic factor to raise the level of patient adherence to treatment and to reach the desired goals.

#### Do you think it is possible for diabetics to achieve the mentioned balance in work environment?

The answer is simply "yes" diabetic can achieve this step successfully and keep blood sugar level under control, but it takes some preplanning, organization and mutual cooperation with work environment which considered a unique and important factor to treat diabetes, as employees spend more than one-third of their lives at work also they are predisposed than others to contribute to health education and participate in work activities in the workplace. So we assure that through education and some perseverance, educational diabetes can achieve important results in the management of diabetic



patient's treatment and prevention of complications.

#### What are the important tips that you would like to recommend for diabetics?

The step of informing your manager or colleagues about diabetes is considered a personal decision, but if you preferred not to share this information, it is still important to involve one or two trusted colleagues about your strategy in diabetes management, especially about the warning signs of low blood sugar, as they can help you to get the appropriate treatment if you faced any complications. Also, discussing your diabetes with your direct supervisor is important to keep him aware of your medical case and other complications that may affect your daily work performance, and can discuss topics such as the possibility of providing some of your needs such as sugar screening device to check blood sugar level during working hours, and schedule shorter breaks, eating snacks that allows the patient's examination of blood sugar levels on a regular basis where such simple functional facilities may help to create a professional healthy balance between the patient and work environment.

One of the useful tips is not to rush out in the morning without a meal it's important to start your day with a good breakfast and if time is a problem, try to prepare it one night before, in order to have it at work directly. There are several good bounties for breakfast such as fresh fruit juice, a low fat sandwich, whole wheat muffins with fruit and milk or yogurt also you can bring healthy snacks to work as regular snacks throughout the day will allow you to maintain your blood sugar and ensure better performance at work. Also it is important to drink plenty

of fluids throughout the day,

especially water, and incase of high blood sugar levels you should avoid drinking coffee and drinks containing caffeine and drink water or sugar-free drinks as well as getting maximum amount of physical activity or exercise during work hours, as the physical activity helps to control blood sugar levels and fortunately there are plenty of ways to get some physical activity methods in the workplace such as discuss some of the work topics while you walk around the building or standing while talking on phone instead of sitting on your desk, walking during your lunch break, join the fitness center at work and use the stairs instead of elevator to move between floors of the building. Incase your job is causing a high psychological pressure; you must learn how to integrate dealing with stress techniques as a routine part of your day at work as the psychological stress plays a major role in regulating of blood sugar levels. Practicing exercises such as deep breathing, meditation, taking a short break or a quick walk away from your desk will help to relieve stress and thus also helps to regulate blood sugar naturally, therefore, dealing with the psychological stress is essential in professional life for diabetics. Also we must realize that diabetes can adversely affect feet health , therefore good care of your feet should be provided during

working hours, as it is essential for diabetics also wearing appropriate shoes helps in the prevention and treatment of complications of the disease, and should remember to wear a new pair of absorbent cotton socks every day as well as examining your feet at the end of a long working day and make sure you don't have cuts or sores, In case of injuries or signs of infection you should go to a specialist doctor to get appropriate care and treatment promptly.

#### What would you like to add in conclusion?

Finally, I would like to emphasize that work environment is a unique and important factor to treat diabetes and prevent its complications, joint efforts and cooperation of employers with their staff can create distinctive work environment that leads to a professional healthy balance between diabetes and work environment, as the possibility of creating a healthy work environment capable to support diabetics for the benefit of society as the studies have shown that investment of employers should be in the health of their employees, especially those who suffer from chronic diseases, that leads to higher rate of job satisfaction, enhancing productivity and reduce health care costs in general, as well as improving their employees physical and mental health.
